## Which units are covered by these enhanced Limited Warranties?

**Goodman** and **Amana** brand units manufactured on, or after, January 1, 2019, (serial number 1901XXXXXX and beyond) will retroactively qualify for the 2-Year Unit Replacement Limited Warranty, and **GMC** brand units will qualify for 7-Year Parts and Compressor Limited Warranties.
